Council Meeting Minutes – August, 2017

GENERAL NOTES:

I. OPENING PRAYER

Pastor Jody led us in prayer.

II. APPROVAL OF MINUTES (Andy)

Motion to approve by Erik, seconded by Amy. Minutes approved.

III. FINANCIAL REPORT (Alice)

- Alice reported that the numbers look a little skewed because of \$5,000 for 2nd Quarter Outreach distribution that was included in Total Expenses. On the Balance Sheet, July payroll taxes were listed under Liabilities. She also drew our attention to the Gateway ONA Fund balance so that we can distinguish between what money is actually going to ONA vs. what is being used for the ministry. We will be taking this out of the Outreach Fund to give it its own line. There was a question about the balance remaining in the Brueggjenjohann Memorial Fund because the original plan was to use it for the parlor expenses, particularly the furniture, so it will be used to pay back Small Building Projects for the money owed. Andy and Alice discussed Outreach Fund activity. The Youth Mission Trip was over-budget, so ideas were entertained regarding how to make this up.
- We haven't received payment for the kitchen for the month of July so discussion ensued regarding where the copy of the contract is located and who the contact person is for this. We'll have Joyce try to make contact and ask some questions. We will also ask Dan to review the contract about specifics.
- Since we are nearing the end of the third quarter, do we need to do a better job keeping the congregation informed about how finances are doing? Maybe include again in the Bulletin? Concerns that it can be demoralizing when we are in a deficit, when we are doing well it can also cause people to back off because they think their contribution isn't necessary. Sue recommended reporting quarterly on what overall income and expenses look like. We want to be transparent and will gladly answer anyone's questions regarding these, but is it something we need to publish? This is something we'll discuss more at the retreat.

IV. PASTOR'S REPORT (Jody)

- Pastor Jody reminded us that the office will be closed Monday and Jill & Joyce will be trading hours next week. Sarah's first day back will be September 1st, followed by her first Sunday back on September 3rd.
- September 16th is the fall clean-up work day.
- The guest organist who played in June lives in the neighborhood and asked Jim T if he could get permission to use our organ for practice. We'd like to get references and make sure someone is available to let him in. Jody will talk more with Jim T. We'll discuss more via email before approving.
- Attendance is back to normal now that school is back in session.

Pastor Jody and Bethel met after the last Council Meeting. They came up with the idea of talking with Anna M. about the Freedom School and the community component that could be used. Jennifer and Pastor Jody named some other resources they discovered that might help in our efforts.

- Bethel reminded us that we are trying to get people interested in going to a play and dinner together at the end of September (details in the Builder).
- Sue brought up reviving our New Member Dinner, so we'll try to come to September's meeting with some possible dates for this.
- Andy recommended a board game/potluck dinner night possibly in February or even a trivia night.
- Andy brought up questions about forming a ministry team to plan events, and maybe also reach out to members who haven't come to church in a while. Should these be paired or separate? Who really is in charge?
- Bethel's ministry team thought that our sign was very plain, not very thought-provoking. Could we ask for new ideas? Maybe just provide Pastor Sarah with ideas. Evangelism and Communication Ministry will bring it up at their next meeting.

- A suggestion was made to have liturgists introduce themselves and welcome visitors. Recommendation to have those making announcements introduce themselves and maybe say what ministry they are representing with their announcement.

Gift Cards

Request for Alice to check what our need is for gift cards in the office and ask the person who is contributing a donation if putting the money toward gift cards would be a good idea or if they have something else in mind.
